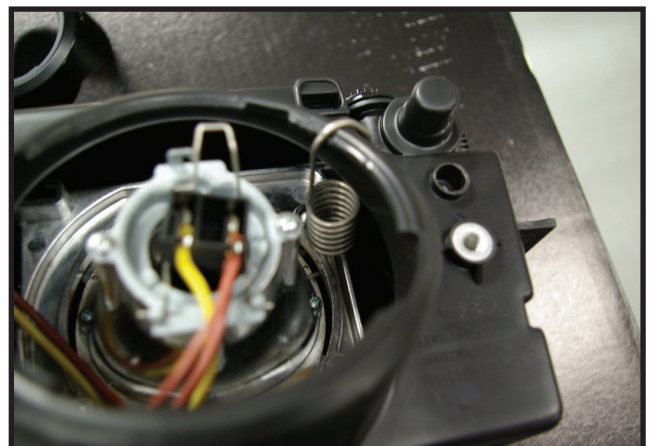
SAFETY WARNINGS



- Use only the parts supplied by ipd to install this kit
- Check ALL the fasteners for tightness before and after road testing the vehicle
- Do not use air impact wrench when re-installing bolts as stripped threads may result

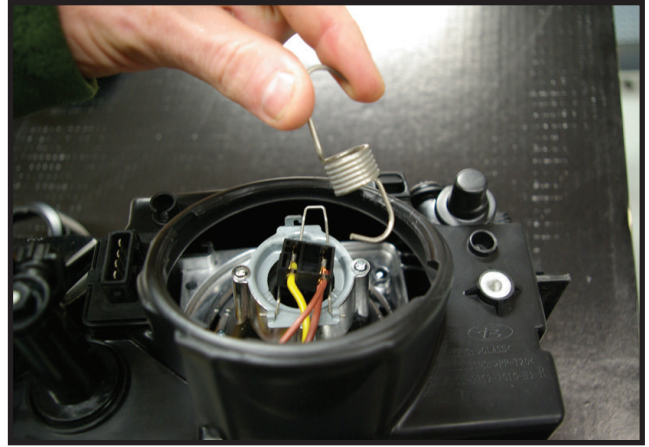
REMOVAL

- 1** ipd's projector lights for 70 series models 1998-2000 are shipped with an included shipping spring.
- 2** The purpose of the spring is to maintain headlight integrity during shipping and maintain a fixed position which prevents any potential damage to the adjusting mechanism.



INSTALLATION

- 3 Before installation simply remove and discard this spring.
- 4 Use a pair of small nosed pliers to pull the springs away from the plastic housing and allow it to come loose from the edge of the interior light housing.
- 4 Install your existing headlight bulbs into the new headlight assembly and install into the vehicle!



FOR YOUR INFORMATION

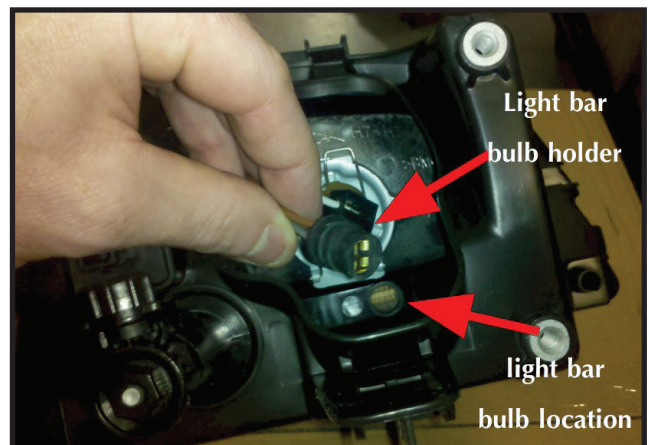
The ipd headlight kits do not come with any bulbs pre-installed, however for both high and low beam your original bulbs are a direct replacement and you can simply re-use them.

The additional light bar at the bottom (city light) requires an additional bulb be installed if you want to use this light. These bulbs are include with our headlight kit.



Note the picture at right, the bulb holder from the light bar in the projector headlight to show its location

Be advised there was a factory recall (Recall 101) that added a short 6" resistor harness in line to the factory connector. This resistor harness only has three wires vs. the four wire connector that these housing use. So you can simply remove it and use the stock connector right to this headlight assembly if you find the light bar still doesn't operate with a bulb installed in that location.



WARRANTY

One Year Limited Warranty

ipd warrants to the original purchaser that the parts manufactured and/or sold by ipd (the Product) is free from defects in material and workmanship under normal use. ipd warrants that the Product will perform substantially in accordance with the specifications set forth in the documentation provided with it. The above express warranties are made for a period of the lesser of 12,000 miles or 12 months from the date the Product is installed in your vehicle.

Any improper use, operation beyond capacity, substitution of parts not approved by ipd in writing, any alteration or repair by others, or any removal, defacing or altering of the identification shall void this warranty. There is no warranty on high-performance or race related parts due to the nature of usage.

The purchaser shall notify ipd at 1-800-444-6473 of any defect within the warranty period no later than thirty (30) days after purchaser discovers the defect. Should any failure to conform to this warranty appear within the warranty period, ipd shall, on notification, correct the nonconformity at its option, either by repairing any defective part, or by making available, FOB ipd's plant, a repaired or replacement part. The purchaser must insure any defective item being returned because ipd does not assume risk of loss or damage while in transit. No payment or reimbursement shall be made for installation, removal, transportation or other charges. The remedies set forth in this instrument are exclusive, and the liability of ipd with respect to any sale shall not exceed the price of the product on which the liability is based.
