# **Installation Instructions**

# Pertronix Ignition for 122 and 1800 Volvos 1962-1969 ipd #E106




## INSTALLATION

For cars using factory coil (i.e. armored cable from ignition switch to coil) with only one small terminal on coil:

Using these instructions you will not cut into the armored cable. Attach the optional red diode leads (with ring terminal) to the red lead coming from the ignitor module. Since the diodes are directional make sure you install these leads as shown in diagram A on the reverse side. Locate the green wire coming off the


started solenoid (if there is no green wire it will be the smallest gauge wire). Attach one diode lead pigtail to the green wire or it terminal. Attach the other diode lead pigtail to a good 12 volt source that is hot when the key is in the "on" position.



# INSTALLATION

#### 1800 Tachometer Hook-up:

For all 1800 models with factory current sensing tachometer, connect the black wire coming from the module to the white wire from the tachometer. Connect the red or white wire from the tachometer to the negative side of the coil. This places the tachometer in the circuit going to the coil.



### **One Year Limited Warranty**

The purchaser shall notify <code>ipd</code> at 1-800-444-6473 of any defect within the warranty period no later than thirty (30) days after purchaser discovers the defect. Should any failure to conform to this warranty appear within the warranty period, <code>ipd</code> shall, on notification, correct the nonconformity at its option, either by repairing any defective part, or by making available, FOB <code>ipd's</code> plant, a repaired or replacement part. The purchaser must insure any defective item being returned because <code>ipd</code> does not assume risk of loss or damage while in transit. No payment or reimbursement shall be made for installation, removal, transportation or other charges. The remedies set forth in this instrument are exclusive, and the liability of <code>ipd</code> with respect to any sale shall not exceed the price of the product on which the liability is based.

EXCEPT AS STATED OTHERWISE IN THIS WARRANTY, **ipd** MAKES NO WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
